Eligibility & Skills Assessment:



We will schedule a meeting with you the trainee to conduct a thorough eligibility and skills assessment. This assessment will comprehensively evaluate your existing knowledge, skills, and experience, including an LLND (Language, Literacy, Numeracy and Digital Literacy) assessment. The goal is to determine your eligibility for the training program and identify any potential opportunities for Recognition of Prior Learning (RPL) or Credit Transfers. This information will then be used to create a customised Personal Learning Plan.

Following confirmation of your eligibility and the most suitable training pathway, we will schedule a meeting with you and your employer to collaboratively finalise the Training Plan. This meeting will cover the responsibilities of all parties, determine the specific units, delivery and assessment methods, and agree on a realistic training schedule. Upon completion, you, the trainee, and we, as the RTO, will sign the finalised Training Plan.

Enrolment



Once eligibility has been confirmed and the Training Plan finalised, you can enrol in the TAE40122 Certificate IV in Training & Assessment. An outline of the course and the units of competency you will complete are on the next few pages of this information pack..

Compulsory Tuition Fee



The User Choice Funding program requires a minimum tuition fee of \$350. We will invoice you directly for this fee. Once payment has been made, your learner portal will be activated, and learning can begin. Fee exceptions and concessions may apply.

WHAT IS THE TAE40122 CERTIFICATE IV IN TRAINING AND ASSESSMENT?

This entry-level program is designed for any person who wants to become a trainer and assessor or who is currently working in an RTO (under supervision) or in a non-RTO training environment and wants to get formally recognised.

To enter this qualification, you must show you have vocational skills and experience in the industry area you want to teach and assess within.

If you want to get recognised for your existing training skills or you want to become a trainer for the first time to share your industry knowledge then this is the perfect program for you!

- Certification to teach and assess accredited courses.

Information Regarding Fee Exemptions and Concessions:

- Fee Concessions: If you hold a current Health Care Card, Pension Card, or can demonstrate genuine hardship, you may be eligible for a fee concession. Please chat to us if you would like to apply for a fee concession.

YOUR LEARNING JOURNEY

Completion

Upon successful completion of all units of competency, you will be awarded the TAE40122 - Certificate IV in Training and Assessment qualification. It is important that you complete the Traineeship within the course duration. As this course is self -paced, you may achieve this qualification ahead of schedule. If you do not complete within the designated timeframe, an extension to the traineeship may be necessary.
