YOUR ENROLMENT JOURNEY

Eligibility & Skills Assessment:

1



We will schedule a meeting with you the trainee to conduct a thorough eligibility and skills assessment. This assessment will comprehensively evaluate your existing knowledge, skills, and experience, including an LLND (Language, Literacy, Numeracy and Digital Literacy) assessment. The goal is to determine your eligibility for the training program and identify any potential opportunities for Recognition of Prior Learning (RPL) or Credit Transfers. This information will then be used to create a customised Personal Learning Plan.

Develop and agree on the Training Plan

Following confirmation of your eligibility and the most suitable training pathway, we will schedule a meeting with you and your employer to collaboratively finalise the Training Plan. This meeting will cover the responsibilities of all parties, determine the specific units, delivery and assessment methods, and agree on a realistic training schedule. Upon completion, you, the trainee, and we, as the RTO, will sign the finalised Training Plan.

Compulsory Tuition Fee

The User Choice Funding program requires a minimum tuition fee of \$350 (non-refundable). We will invoice you directly for this fee. Once payment has been made, your learner portal will be activated, and learning can begin. Fee exceptions and concessions may apply.

- Individuals working in TAFEs, RTOs, or corporate training environments

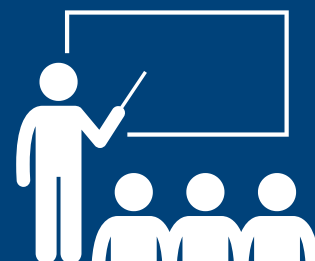
This Diploma requires you to choose one of three specialisations, and your choice will depend on your current role plus your career aspirations.

- 1 - Advanced Training and Assessment
- 2 - Design and Development
- 3 - VET Leadership



1. Advanced Training & Assessment

The TAE50122 Diploma of Vocational Education and Training (Advanced Training and Assessment) is for people in or looking for Advanced training and assessment job roles where individuals are responsible for delivering training and assessment services in the VET sector, including promoting innovative practices and leading other VET teachers, trainers and assessors.



2. Design & Development

The TAE50122 Diploma of Vocational Education and Training (Design and Development) is for people in, or looking for, design and development jobs where you are responsible for designing and developing training and assessment strategies, usually for RTOs, including analysing training needs and designing training solutions and products to meet industry standards and compliance requirements.

3. VET Leadership

The TAE50122 Diploma of Vocational Education and Training (VET Leadership) is for those leading and managing others in an RTO, ensuring continuous improvements and compliance within the VET Sector.



HOW WE'VE PACKAGED EACH SPECIALISATION

The TAE50122 Diploma of VET requires the completion of 12 units of competency (3 core units and 9 elective units).

Students will select from 3 specialisations according to their area of expertise or career aspirations.

The specialisations require 5 of the 9 elective units to be selected from a specific group appropriate to the specialisation selected.

Information Regarding Fee Exemptions and Concessions:

- **Fee Exemptions:** You may be eligible for a full fee exemption in specific circumstances, such as if your employer is the training provider, or if you are transitioning between employers within 12 months for the same qualification. You can discuss potential eligibility during your pre-enrolment discussion.
- **Fee Concessions:** If you hold a current Health Care Card, Pension Card, or can demonstrate genuine hardship, you may be eligible for a fee concession. Please chat to us if you would like to apply for a fee concession.

Training Delivery



The course is delivered online, which allows your trainee to learn flexibly and at your own pace, enabling you to balance your work and responsibilities effectively. All learning materials and assessment resources are accessible online. Your trainee will work through the lessons and content at your own pace and submit your assessments online.



A dedicated trainer will check in regularly with you – at least every month – to provide support, answer any questions, and ensure you stay on track with the timelines outlined in the Training Plan. You will keep a record of your learning and application in the workplace by completing a workplace activity log. This log will be signed by both you and your workplace supervisor to confirm the application of your learning in the workplace. This log will be submitted with your practical assessment for each unit.

Supervision in the workplace: As part of the traineeship, you will be allocated a designated workplace supervisor to provide ongoing support throughout your studies. This includes allocating sufficient time to complete required workplace activities and engage in relevant learning experiences. This support is crucial for the successful completion of the traineeship.

Upon successful completion of all units of competency, you will be awarded the TAE50122 – Diploma of Vocational and Education qualification. It is important that you complete the Traineeship within the course duration. As this course is self-paced, you may achieve this qualification ahead of schedule. If you do not complete within the designated timeframe, an extension to the traineeship may be necessary.
